

## **SUPER SUNDAY STOCKING STUFFER**

**Earning Dates:** Sundays December 6, 13 and 20, 2020

**Drawing Dates:** Sundays, December 6, 13 and 20, 2020

**Times:** 1pm – 5pm

**Drawing Location:** Timber's Grille (former Players Club #1 location)

1. Seven Feathers Circle Players Club membership is required.
  - a. Membership is free.
  - b. Guests must be 21 years of age or older; and
  - c. Guests must present a valid photo ID to become a member.
2. Guests will earn one (1) entry for every 100 base points earned throughout the promotion time frame. Guests will earn entries each Sunday during the promotion beginning at 8am – 4:55pm.
3. Guests will earn one (1) free entry per week per promotion time frame.
4. Once guests have earned one hundred (100) base points, they may redeem entries from the Players Club. Guests may earn a maximum of fifty (50) entries per Sunday.
5. All Dogwood Diamond guests may receive an extra fifteen (15) entries each week.
6. All Elite guests may receive an extra ten (10) entries each week.
7. All Preferred guests may receive an extra five (5) entries each week.
8. All Select guests may receive one (1) free entry each week.
9. Guests will be responsible for redeeming entries, maintaining them, and dropping them into drawing drum per promotion time frame. No reprints.
10. Points earned/entries do not roll over once the promotional time frame has ended.
11. All vouchers/entries will be removed from the drawing drum each Sunday once the final winner has been selected/named.
12. The drawing drum will open each Sunday at 10am. The drawing drum will be located near Timber's Grille (former Players Club #1 location).
13. The drawing drum will close two (2) minutes prior to each drawing.
